BY-LAW NUMBER 04-2020

A By-Law to amend Zoning By-Law Number 25-98, as amended.

WHEREAS the Municipal Council of the Corporation of the Township of South-West Oxford deems it advisable to amend By-Law Number 25-98, as amended.

THEREFORE, the Municipal Council of the Corporation of the Township of South-West Oxford, enacts as follows:

1. That Schedule "A" to By-Law Number 25-98 as amended, is hereby amended by changing to "ME-4" the zone symbol of the lands so designated "ME-4" on Schedule "A", attached hereto.
2. That Section 20.3 to By-Law Number 25-98 as amended, is hereby further amended by deleting and replacing the following subsection:

"20.3.4 LOCATION: Lot 29, Concession Broken Front (West Oxford), ME-4 (Key Map 30)"

- 20.3.4.1 Notwithstanding any provisions of this Zoning By-Law to the contrary, no *person* shall within any ME-4 Zone *use any lot, or erect, alter or use any building or structure* for any purpose except the following:


a building, structure or use accessory to a permitted use;
a conservation project;
a farm, but does not include a regulated farm as defined in this Zoning By-Law;
a licensed sand or gravel pit and accessory processing activities limited to crushing, screening, stockpiling and storage of aggregate products;
a wayside sand or gravel pit or stone quarry in accordance with the provisions of Section 6.33 of this Zoning By-Law;
farm buildings and accessory single detached dwellings as existing on July 9, 2019.

- 20.3.4.2 That all the provisions of the ME Zone in Section 20.2 to this Zoning By-Law, as amended, shall apply, and further that all other provisions of this Zoning By-Law, as amended, that are consistent with the provisions herein contained shall continue to apply *mutatis mutandis*."



NOTE: ALL DIMENSIONS IN METRES




